Election of Officers

• Conceptual Consultation - 44 Pinewood Road.

Mr. Michael Donnelly, owner of the proposed Child Day Care Center at 44 Pinewood Road, discussed the proposed layout and operation of the center based on a conceptual Site Plan that was submitted to the Board. It was noted that Mr. Donnelly had previously been granted a Waiver by the ZBA to allow the operation of a Child Day Care Center (7 or more) on a property in the Commercial Light Industrial Zone, and that he proposes to convert an existing structure (church) on the property into the center.

Mr. Donnelly stated that there would be no changes to the outside of the structure except for adding a fenced-in play area to the rear and adding egress doors in the rear to access the play area. He also discussed how parents would access the center for drop-off and pick-up via a circular one-way system and that he proposes to have approx. 13 parking spaces on site. Four to eight (4-8) of the spaces would be for the use of employees and the remainder for parents in those situations where they might have to be on property for longer than typical drop-off and pick-up activities. He expects the center to cater for approx. 34 children but that is subject to the State of New Hampshire who will determine the maximum allowed capacity.

Mr. Arsenault advised that the approved ZBA Variance is currently under the 30-day wait period for any potential appeal of the decision, which was granted on Mar 13, 2024.

Following some clarifying questions from the Board, neither the Members, Building Inspector/Code Enforcement Officer nor Planner expressed any concerns with the proposed plan.

It is noted that Conceptual Consultations and any opinions or views expressed by the Planning Board or applicant are non-binding on either party.
