- Boys and Girls Club Possible Alteration of Building





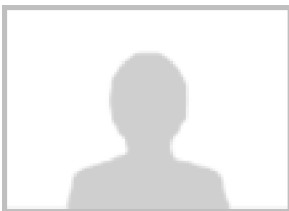

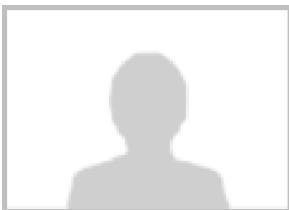
