Mr. Goodine read a report from the docket in regards to the school funding system based on a ruling regarding ConVal.

The Hynes case will be closed out.

At the next meeting we will have a public hearing on acceptance of extra highway block grant funds in the amount of \$26,878.03. Chad wants to encumber those funds for paving in the new year.

ROAD AGENT REPORT

Chad Pelissier stated that they received utility poles and cross ties that have been put up for the salt shed and they are ready to order trusses. He got two prices and is waiting on a third. Lavalley came in as the cheapest so far at \$6738.65 for the trusses. He is looking for an ok for that amount and if the third quote comes in cheaper, he will go with them.

Mr. Klawes suggested voting on the cost of the trusses and the roof so if he has an opportunity to get the roofing he can.

Chad said he can wait the two weeks until the next meeting.

Ron Adinolfo said if the town does not keep up with the COLA, then we are behind other communities.

Mr. Klawes asked the Board if the town needs to hire a maintenance person to take care of the buildings to do the work instead of contract services. This would not be a cleaning person but specifically a maintenance person.

Ms. McKenney said she has been working on the appointment list. There are some that she does not have an appointment sheet on and will get one to those who need it.
