ROAD AGENT REPORT

Mr. Goodine said there is a fence that is potentially in their right-of-way that is impeding the

possibility of snow removal. He said that they have no obligation to fix it if it is indeed in the right-of-

way so they need to figure out where the property pins are.

Mr. Pelissier said he is not worried about fixing the fence, but it's going to keep recurring with every

snow storm.

Ms. McKenney said there is a tree by Letendre Avenue that is not in great shape but Eversource was

able to take care of some of the problem.

Mr. Pelissier said they will add paving bids to the next agenda.

Ms. McKenney said the Planning Board has been going over the Hazardous Mitigation and she wants

to put something out to all the Department heads so they can update it. Mr. Pelissier said it is easier

to do it as they go as opposed to waiting every five years.

Mr. Pelissier said they are trying to get telephone poles on Valley Street moved.

Mr. Goodine said they have a \$50,000 grant that Chief Stark is working on to replace fire and police

radios.
