April 4, 2022

Call to Order

The Allenstown Selectboard Special Meeting of April 4, 2022 was called to order at 6:08 PM by Chair Scott McDonald.

Chair McDonald called for the Pledge of Allegiance.

CITIZENS' COMMENTS

Mr. Frascinella has noticed while driving around the area that several roads including Chester Turnpike have been posted "load limit 6 tons" but there is still excessive heavy trucking on Deerfield Road. Chair McDonald said he is still seeing it on Chester Turnpike.

Mr. Klawes said the 6 ton limit is because of the unstable roads, but Mr. Frascinella is referring to the traffic on Deerfield Road which is not going to change and probably will only get heavier. He said that it is a route that they have to take and there is no other way to get out there.

REGULAR AGENDA

- **Acceptance of Funds under RSA 95-b, II I,b - (less than \$5,000) for Fire Suppression Equipment- Total Project Estimated Cost + \$1,961.50- Grant Total \$980.75**

Chief Lambert said this funding was something that was started last year. He said it is \$1,961.50 for the total project and the grant is \$980.75.

Mr. Klawes made a Motion to accept the grant funds in the amount of \$980.75 for Fire Suppression Equipment. Ms. McKenney seconded the Motion.

Chief Lambert said they can apply for that grant bi-annually and it is something to look forward to.

- **Fire Station Improvements**

Chief Lambert said a few years back, they had to pay to have the foundation repaired and lifted, because part of the rear knee wall of the foundation sunk. When it was fixed, it caused separation and crack in the drywall, seams and elsewhere. He said they need to repair the seams professional to stop the heat escaping and preserve it, along with painting all of the bay. He would also like to vinyl wall board all around the perimeter of the wall 8 ft. to protect from water, grease, snow, dirt tools, etc.

Chief Lambert said he and Jeff Gardner did some research and contacted at least 10 companies and most companies are already booked for a long time period going forward. He said it's a big project that will require staging. There has been one quote so far and it was from last year but they are willing to honor their quote and he is looking to see if they can use some of the funds from the Public Safety Fund to put toward this project.

The quote is for \$21,900.

Ms. McKenney said if it is not done, it is just going to get worse.

Chief Lambert said in the future, they may want to fix the upstairs, along with other maintenance as the building is 21 years old. He said some of it is small stuff that they can just do on their own.

Mr. Klawes said he would not be surprised if they came back to them for more money after they began work on the project. Chief Lambert said finding a vendor that will commit to them for a project of this size is proving to be difficult.

Mr. Klawes made a Motion to Public Safety Building Capital Reserve Fund in the amount of \$21,900. Ms. McKenney seconded the Motion.

Mr. Gardner said there are a lot of factors that come into play and they should look into upgrading their bandwidth etc. Mr. Goodine said he thought they had previously updated. Mr. Goodine and Mr. Gardner will discuss this together at a later date in order to resolve.

Building Inspector Inter-Municipal Agreement with Pembroke

Mr. Goodine said the Pembroke Selectboard signed the agreement and now they just need Allenstown Selectboard to sign it.

Chair McDonald made a Motion to approve the Inter-Municipal Agreement with the Town of Pembroke. Mr. Klawes seconded the Motion.

Mr. Goodine said he has nothing new to report.

TOWN ADMINISTRATOR'S REPORT

Mr. Goodine said that he was in an motor vehicle accident and is still recovering and trying to catch up at work.

The starting date for the new Finance Director, Sherry Miller, will be April 11th. He said she worked this past Saturday to learn the ropes with Deb Bender and seems to be a good fit.

Mr. Goodine said there won't be a Road Agent Report but at the next meeting they will probably be having the people from Reserve Street come in to discuss the tree. He said he will write letters inviting the residents to the next meeting, but it's up to the Board to decide whether it is truly a nuisance.

Ms. McKenney said Carl Schaffer resigned from the School Board. She said she would like to send him a Certificate of Appreciation for all his services provided to the Town. Everyone was in agreement.

Mr. Goodine said the new school's website has been updated. He said the Wednesday's Planning Board meeting will be discussing the plans for the school. He said there has been a lot of chatter on social media and he isn't sure how many residents will show up.

Mr. Arsenault said the issues they originally had are ironed out and he expects Wednesday to go well. He has not received any phone calls from the public as of yet. He did receive a notice from the designer regarding a meeting at the Fire Station about the plans but he hasn't heard anything further regarding a date.

Mr. Goodine said there was a posting on the new school's website of the Wildlife Assessment which was a response to the eagle rumor. He said they also posted the newest floorplan of the school.

Mr. Goodine and Ms. McKenney discussed that certain stipends were rounded up but he does not consider that a raise or a COLA increase. Ms. McKenney said she would have given them more.

Mr. Goodine said he provided the Board with the Veteran Application, Gopher Application for the radio grants, Law Enforcement Drone Use Agreement for Bear Brook, elderly exemption, and an appointment form as well.

Mr. Goodine said he wanted to mention that he gave the wrong information regarding the bridge schedule. He said they are going to start April 25th and it will not wrap up until 10/13/23.

Mr. Goodine said there is an abatement related to the school and Matt Monahan's contract that need signature.

Mr. Arsenault said the Wetlands Permit for the school was delivered last Monday to the state.

Mr. Goodine said they received a letter for the Children's Fishing Derby by Suncook Valley Rod and Gun Club asking for sponsorship. He said generally speaking, they do not do that.




