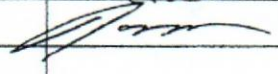

- That professional stamps and signatures as well as owner signatures need to be on the final plan.
- All waivers granted and conditions of approval need to be on the final plan.
- Notice of Decision to be recorded at the Merrimack County Registry of Deeds.

Based on the review of the Operating Standards and Reclamation, the Excavation Permit, and the request for a waiver of up to 5 years, with the Conditions of Approval as read by Matt Monahan, the Chair requested a motion to approve the application. Motion Made by Diane Adinolfo. Motion seconded by Sandy McKenney.

- a. Gilmanton Planning Board – Notice of Regional Impact & Public Hearing

The Chair advised that the Planning Board had received a notice of Regional Impact and Notice of Public Hearing from the Gilmanton Planning Board. The notice was in regard to an application for a Wireless Telecommunications facility to be located on the property of Mr. Charles A. Price, physically located at NH Route 140, Gilmanton, NH.
