#### OLD BUSINESS/RECEIPT OF APPLICATIONS & PUBLIC HEARINGS

a. MS4 Post Construction Ordinance Review

Chair O'Meara stated that the Board would be reviewing edits to the Post Construction Ordinances made at their November meeting.

Mr. Monahan referred to Section XXV, noting that the date in 1-A has been changed to March 10, 2020. He stated that most of the revisions are minor, involving grammar, spelling, rewording and clarifications. Acronyms have been spelled out, as necessary, and redundancy has been eliminated. A definition of 'disturbed area' has been added. Because some parts were taken from a model ordinance, some numbering has been adjusted for accuracy in referencing.

Mr. Monahan suggested beginning in October with a public information session, followed by a public hearing.

Chair O'Meara agreed with this plan, as did the members of the Board in attendance.

Mr. Monahan said he would work with Mr. Goodine to establish necessary website links.

# NEW BUSINESS/RECEIPT OF APPLICATIONS & PUBLIC HEARINGS.

a. Revisions to Groundwater Protection Ordinance

Chair O'Meara next addressed the review of the revised Groundwater Protection Ordinance, draft #2, dated January 2, 2019.

Mr. Monahan said that the most important factor is to make sure that these two ordinances refer to each other correctly. The threshold was changed from 2,500 square feet to 5,000 square feet.

Mr. Frascinella pointed out that in Section IX, A & B, it should say '15% or 5,000 square feet' instead of '15% or 2,500 square feet'.

Chair O'Meara suggested visual examples might be helpful for the public information session.

Ms. Adinolfo suggested a PowerPoint presentation.

Chair O'Meara said that he and Mr. Monahan should meet with the BOS to discuss the section which is their responsibility: illicit discharge.

Mr. Monahan said that Mr. Ronnie Pelissier of the Highway Department will be pleased to have enforcement and fines concerning many illicit discharges which hinder his operations.

Chair O'Meara set the date of February 6, 2019 for the next Planning Board meeting.
