#### UNAPPROVED MINUTES

a. Review and approve minutes from the February 06, 2019 meeting.

#### CORRESPONDENCE & OTHER BUSINESS

a. Chair O'Meara presented a Notice of Regional Impact regarding a development in Pembroke. He said that the public hearing has already been held. He noted that Mr. Pelissier asked to review the notice. Chair O'Meara said that this is a major subdivision of Lots 43 and 45, 373 Fourth Range Road, at the top of Pembroke Hill. This will create 48 lots for homes, one of which is unbuildable. There will be a new road created, improvement of Fort Range Road and Robinson Road. There will be private on-site wells and septic systems. Chair O'Meara said he will respond that Allenstown sees no impact from this development.

Mr. Pelissier noted the odd shape of many of the lots.

- b. Chair O'Meara reported on a letter of solicitation from Dubois & King, Inc. This company has many locations, including one in Laconia. They provide engineering services similar to those offered by Hoyle Tanner and Associates, which Allenstown employees. Dubois & King provides engineering services, including town planning, town engineering, planning board reviews, site design, transportation engineering, water and wastewater engineering, water resources engineering, mechanical engineering, electrical engineering and construction engineering. Chair O'Meara said that he would place this letter in the Planning Board file.
- c. Chair O'Meara said that he just heard that the US EPA has approved the town's permit for MS4 compliance regarding the discharge of stormwater in the MS4 area. The Town

had filed a Notice of Intent (NOI). The permit expires June 30, 2023. The annual update is due September 30, 2019.

# DESIGN REVIEW APPLICATION SITE PLAN

Application for design review of a site plan for the design and construction of a telecommunications facility, 11 Mohawk Drive, Map 6 Lot 35-3, Zoned C-I, Tahoe Realty Holding, LLC (Owner) & Bay Communications III, LLC and T-Mobile Northeast, LLC (Applicants)

Design review is a process involving nonbinding discussions with the applicant and the Town beyond conceptual and general discussions, which may involve specific design and engineering details. Under this process, the submitted plans and information are reviewed by the Town's Design Review Committee (DRC) and/or the Town's engineering review consultant. Within 30 days of receipt of a complete Design Review Application and all items specified in Section 2.04.b of the Town of Londonderry Site Plan Regulations, the DRC shall review the submitted plans, and any comments will be forwarded to the applicant. No public hearing on the application during design review shall be scheduled unless requested by the applicant.

Please note that the plans & files for the above referenced projects are available for review by the public in the Planning & Economic Development Division Office, second floor of the Town Hall.
