Monday, November 9, 2015 First day to accept petitions to amend zoning ordinance or building code for consideration at the 2015 town meeting (RSA 675:4; 40:13, VII)

DECEMBER

Wednesday, December 9, 2015 Last day to accept petitions to amend zoning ordinance or building code for consideration at the 2015 town meeting. (RSA 675:4; 40:13, VII)

Friday, December 28, 2015 Last day to post and publish notice of first hearing on proposed adoption or amendment of zoning ordinance or building code if a second hearing is anticipated (RSA 675:3; 675:7; 40:13, II-a(c))

JANUARY

Monday, January 4, 2016 Board of Selectmen public hearing on the proposed bond warrant article and any special revenue funds proposed.

Tuesday, January 5, 2016 Last day to hold first public hearing on adoption or amendment of zoning ordinance or building code if a second public hearing is anticipated (RSA 675:3; 40:13, II-a(c))

Friday, January 8, 2016 Last day to post and publish notice of final planning board public hearing on proposed adoption or amendment to zoning ordinance or building code. (RSA 675:3; 40:13, II-a(c))

Friday, January 8, 2016 Last day to submit a petition warrant article that proposes a bond governed by RSA 33:8-a. (RSA 40:13, II-a(b))

- Monday, January 11, 2016 (Make-up date) Board of Selectmen public hearing on the proposed bond warrant article and any special revenue funds proposed.
- Tuesday, January 12, 2016 Last day for selectmen to publish notice of time, place and subject of public hearing on bond or note issue over \$100,000. Hearing can be held no earlier than 60 days before First Session. (RSA 33:8-a, I; 40:13,II-a(a))
- Tuesday, January 12, 2016 Last day for giving notice of January 19 public hearing on annual budget (RSA 32:5,I; 40:13.II-a(a))
- Tuesday, January 12, 2016 Last day for voters to petition selectmen to include an article in the town meeting warrant (RSA 39:3; 40:13, II-a(b))
- Friday, January 15, 2016 Last day to hold public hearing on question of establishing a special revenue fund if the first session is to be held on January 30th. Hearing must be held at least 15 but not more than 30 days prior to meeting where question will be voted on. (RSA 31:95-d,I(b)).
- Saturday, January 16, 2016 Budget Committee public hearing on the budget and all warrant articles that include appropriations.
- Saturday, January 16, 2016 Last day to notify affected landowners if town meeting warrant contains an article to discontinue a highway. (RSA 231:43; 40:13,III)
- Tuesday, January 19, 2016 Last day for the planning board to hold final public hearing on adoption or amendment of zoning ordinance or building code. (675:3; 40:13,II-a(c))

Thursday, January 21, 2016 Last day for the Budget Committee to submit its annual budget to the Board of Selectmen.

Saturday, January 30, 2016 Deliberative Session 9 AM (Town then School)

FEBRUARY

Wednesday, February 3, 2016 Make-up date for Deliberative Session 6 PM (Town then School)

Saturday, February 6, 2016 Last day to hold First Session of town meeting. (RSA 40:13,III)

MARCH

Tuesday, March 1, 2016 Annual report with final budget and ballot questions must be available (RSA 40:13,II)

Tuesday, March 8, 2016 Second Session of annual meeting to elect officers, to vote on all questions required by law to be on official ballot, and vote on all warrant articles from First Session of annual meeting.
