

On October 17, 2016, the Allenstown Board of Selectmen executed a Stipulated Decree, which resolved the above referenced litigation. The above-referenced litigation concerned a Declaratory Judgment action filed by the Town of Allenstown against Kathleen Rogers, regarding the application and effect of Article 13 of the 2016 Town Warrant, which was submitted by Ms. Rogers and passed by the 2016 Allenstown Town Meeting. A copy of the Stipulated Decree, as approved by the Board of Selectmen, is reviewable on request at the Town Hall located at 16 School Street, Allenstown, New Hampshire.

The Town and Ms. Rogers will submit the Stipulated Decree to the Merrimack County Superior Court no earlier than October 31, 2016 for execution and approval by the Court. Any person wishing to object or comment on the Stipulated Decree may do so by submitting an appropriate pleading to the Merrimack County Superior Court on or before October 31, 2016.

STIPULATED DECREE

The above noted matter having come before the Court on agreement of the Parties, the following Decree is entered:

In accordance with Article #13 of the 2016 Allenstown Town meeting, the positions of Town Clerk and Tax Collector were combined. Pursuant to RSA 41:45-a, the voters of the Town shall elect one person as Town Clerk/Tax Collector at the 2017 Town meeting to serve for a three (3) year term.

The language in Article #13 of the 2016 Allenstown Town Meeting relative to compensation and benefits to be paid to the elected Town Clerk/Tax Collector for 2017 shall be considered “advisory” only, and shall not be binding on the Town in preparation of the 2017 budget, (see, RSA 32:5; RSA 32:16(1)), nor shall it bind the Town to appropriate any specific amount of money for compensation for the Town Clerk/Tax Collector for the 2017 calendar year (or any subsequent year).

This agreement shall not preclude the submission of further warrant articles pursuant to RSA 41:25 and RSA 41:33 to determine the amount of compensation for the Town Clerk/Tax Collector. Passage of the warrant article shall be binding on the Town, provided that the proposed

compensation is limited to the fiscal year in which the warrant article is presented.
