Call to Order

The Allenstown Selectboard meeting of July 25, 2022 was called to order by Chair Scott McDonald at 6:05 pm.

Chair McDonald called for the Pledge of Allegiance.

CITIZENS' COMMENTS

Mr. Goodine asked Trish Caruso what the details are for the Purple Heart ceremony. She said she was not sure what the final details were but she would ask Mr. Caruso.

Mr. Frascinella said the August 14th concert is going forward and the ARD student council will be selling goods. He said there will also be a car show for a "cruise night" ie. classic cars and is hoping there will be more interest. He said he advertised on several facebook sites.

Ms. McKenney asked why the new signs were not double sided. Mr. Frascinella said they always put the sign in the face of traffic and it was cheaper that way.

Mr. Frascinella said they now have proofs for 5 Hometown Hero banners which was sponsored by the Planning Board. He is hoping to have the banners in a month or so once a printer is located.

This candidate has over a dozen years of experience as a prosecutor and he thinks that she would be a great fit. TOWN ADMINISTRATOR REPORT

Mr. Goodine said they are a lot of people doubtful about the values in Allenstown. He said he was reading a report he received about some properties that sold in town. He said for anyone doubtful, they are accurate.

He said that they have advertised the new full time Administrator Assistant position which was Dawna Baxter's position. He said they have had 28 applications for that. The cutoff date is August 11th. He said he went through most of the applications and printed them out and the Board is welcome to look at them. He would like to interview 8 people or less for the position.

Mr. Goodine said that Mr. Pelissier wanted them to know that they ordered a radiator from China but it won't be due in until October or November.

He said a few people in a particular area may have lost power last week. He said there was a problem when mowing and a wire was hit, but no one was hurt.

Mr. Goodine said he just received a call today that the second grant from the ARPA funds is coming soon. He said they were verifying contact information for that.

Mr. Goodine said the received the June testing for the Community Center when someone called regarding a gasoline scent.

He said he received a letter from Keno about being available at all of the convenience stores but apparently you cannot stay there and watch.

Mr. Goodine said he provided the Gatsas report to the Board, payroll change forms, and Primex invoices that would go to their invoices.

OTHER BUSINESS

Chair McDonald said late last week, his son sent him a photo of a 36 acre piece of property on Route 28 that was for sale.

Mr. Caruso indicated that the ceremony for the Purple Heart would take place at the Community Center on August 7th. He said they have a Purple Heart community and a Purple Heart trail. For the Purple Heart trail, the State has to put up the signs.
