Mike Frascinella stated that the cost of two tables and two double sided grates would be \$3449 plus shipping of \$1285.83 with a total cost of \$4736.00. He would like approval for two tables and two grills and then he will ask the Highway Dept to install them down at the boat launch. He also stated that there were cars from MA and suggested the town residents have a sticker and a sticker can be purchased for out of towners to use the boat launch.

Mr. Klawes stated he has no problem with the stickers, but how would someone get the sticker on a Friday, Saturday, or Sunday.

Ms. Adinolfo suggested they can have it on their phone.

Mr. Goodine suggested that it is too late to do anything about it for this year, but something to look in at for next year.

Ms. Adinolfo and Mr. Klawes feel the grills are a bad idea.

• Volunteer Forestry Assistance Grant Application Approval

Chief Lambert stated they are doing a 50% match up to \$2000 again this year. With all the new hires this year. their forestry gear getting old and they would like to purchase new gear. He asked for approval to apply for the grant.

• Emergency Services Revolving Fund Expenditure Approval

Chief Lambert stated they are looking to use some of the funds in their revolving account to offset their budget. With the new hires and other training, they have done that was mandatory, they are looking for some reimbursement for those costs. Also needs reimbursement for equipment for the stockroom due to the transition taking place in April with EMS. New uniforms are needed for the new hires as well, and for fuel. They will also need the first installment payment for a cardiac monitor. The current balance in their revolving fund is \$37,619.00.

Chair McDonald made a motion to instruct the treasurer to transfer \$16,419 from the Emergency Services Capital Reserve Fund to the Fire Department Operational Budget for the expenses listed above.

TOWN ADMINISTRATORS'S REPORT

Mr. Goodine stated that the people came in to do the testing at the Community Center and had a concern with the wet well. They are concerned that there was no water flowing from the Community Centers drainage system. They are concerned the perimeter piping around the building has become clogged with iron and when the water table rises you may see water in the Community Center. He spoke to Chad today who said they need to do the curbing still to direct the water away from the building. They are going to need to make a cut in the wet well and put a T in it and then some type of clean out so they can get in there and snake out the drain. He has a call with Matt from Milestone, the engineers for the wet well, and Chad on Thursday so they can come up with a solution to do a clean out. He made a correction to the August 2, 2023 minutes.
