# TOWN OF ALLENSTOWN SELECTBOARD MEETING MINUTES 16 SCHOOL STREET ALLENSTOWN, NH 03285 NOVEMBER 6, 2023

#### **CALL TO ORDER:**

The Allenstown Selectboard meeting of November 6, 2023 was called to order by Chair McDonald at 6:00 pm.

Chair McDonald called for the Pledge of Allegiance.

#### • Town Clerk and Deputy Town Clerk

Diane Adinolfo put together an update for the Town Clerk Tax Collector office and shared it with the Board. She gave them statistics for a 24-day period. They will be monitoring how many transactions they do. She explained what they need to do for staffing and training. They have the paperwork to switch roles between Diane and Brittney tonight. She brought a job posting to post for a Deputy Town Clerk. They will wait to see what they get for applicants before deciding if it will be full or part time. There are some technology issues they need to get corrected as well.

## • Nonjudicial Settlement Agreement Between TOA TOTT and Roman Catholic Bishop of Manchester on old Private Trust Funds

Mr. Adinolfo gave an update of the Trust Funds.

Mike O'Meara stated the Trustees currently have 8 perpetual funds. Only one of those is in Allenstown and it is not in a public cemetery. Five of the eight that we manage are interred within the Catholic Diocese of Manchester. We cannot use the funds because they are not in a public cemetery. We can legally transfer the five perpetual funds for those buried in Catholic cemeteries to the Diocese for them to take over the funds.

That leaves three perpetual funds. One is on private land, one is in Massachusetts, and one we cannot find.

Ms. Higham made a motion to accept the Nonjudicial Settlement Agreement pursuant to RSA 564-B:1-111 between the Town of Allenstown Cemetery Trustees, the Roman Catholic Bishop of Manchester, and Department of Justice office of the Attorney General, Charitable Trust Unit effective as of November 14, 2023.

Chief Stark stated a lease agreement for a 2023 dodge ram 1500 pick up truck. Total lease would be \$46,250.9 with an interest rate of 6.99% with tax exempt leasing with a yearly payment of \$15,416.97.

Ms. Higham made a motion that the Town of Allenstown enter a lease agreement with tax exempt leasing to purchase a 2023 Dodge Ram 1500 Pick Up truck for a total of \$46,251.00 with an annual payment of \$15,416.97. She also moved that Police Chief Michael Stark be authorized to execute the agreements on behalf of the Board of Selectmen.

#### Sewer ARPA Grant Extension

Jeff Backman spoke about a grant for \$225,000 for the sewer treatment plant. The stipulation in the original grant agreement was that the money be spent by November 1<sup>st</sup>. They realized a few weeks ago that would not happen. He talked with NH DES and they said they could get an amendment to the ARPA grant agreement.

The amendment requires a vote by the board. The Board should authorize Jeff Backman sign the documents.

#### • Sewer Department Warrant Article for Bond for Town Election 2024

Derik Goodine explained that this is for the new clarifiers at Allenstown Waste Water Treatment Center and they are looking to go for an 11.5-million-dollar bond for purpose of financing the cost of engineering, construction, and clarifiers at the Allenstown Community. There needs to be a public hearing on this and it needs to happen within 60 days of the Annual Meeting. The hearing will be scheduled for 9:00 am on January 13, 2024 with a snow date of January 16, 2024. Jeff stated the bond will be paid by the users of the system.

Mr. Klawes made a motion to accept the Sewer Department Warrant Article for Bond for Town Election 2024.
