Call to Order

The Allenstown Economic Development Committee Meeting of April 13, 2022 was called to order at 6:38 pm by Chairman Mike Frascinella.

Chair Frascinella called for the Pledge of Allegiance.

OLD BUSINESS

- **Ice Rink:**

Mr. Adinolfo said Mr. Pelissier and his co-workers packed the ice rink away. He said they will all meet over the summer to discuss how to make it better for next year.

Mr. Pelissier said the when the sideboards went in, it froze, and then they got rain which pushed the boards up and they would have to physically attach the liner to the boards to resolve this. He said they can put their heads together to come up with a solution sometime before fall.

- **Historic Site Markers**

Chair Frascinella shared his screen to the Board and showed photographs of the various properties with the associated narratives.

Chair Frascinella said that the next step will be contacting property owners and then placing markers at each property on the tour. He said that he already has a template for the markers which will take some of the information from the booklet and then refer them to the appropriate page in the booklet for further information.

- **Commercial Properties**

Chair Frascinella asked if they have figured out who owns Pork Chop Hill. Mr. Goodine said Mr. Pelissier had a lead on the property. Mr. Pelissier said he will try to find it in the next day or so. He said he thought it was just one property for 60 or so acres.

Mr. Pelissier said the Plourdes own it and someone named Danny may be in charge of it.

- **Summer Concerts**

Chair Frascinella said they have the musicians lined up and now they need to do advertising with the yard signs at major intersections and online.

He said that Mr. Venegas did a great job managing the corn hole tournament they had last year, and he would like to include in the advertising material that they would like to do it again. Mr. Adinolfo said they should put it on the website.

Mr. Pelissier said they learned last year not to do a Round Robin tournament but just a single elimination tournament so they can't get through it before the contest ends.

Chair Frascinella said he contacted the fire department and Chief Lambert said he would be interested in bringing the rescue trucks in. He said the library won't be able to make it for the first concert and he is awaiting word back from the ARD Student Council.

- **Town wide Yard Sale:**

Chair Frascinella said that he believes there are only 4 people currently signed up for the town wide yard sale on May 21st. He said they will post a reminder on the town website.

NEW BUSINESS

- **Flags and Banners:**

Chair Frascinella said he contacted the latest Eversource Community Relations Specialist and is still waiting to hear back regarding the poles for the flags and banners. He said at this time, Mr. Pelissier usually puts the flags up with the banners but the timeline is from Memorial Day to Veteran's Day.

- **2022 EDC project list:**

Chair Frascinella asked about improvements to the boat launch. Mr. Pelissier said that they have started doing some clean-up down there and if they can, they will get a couple of picnic tables in before boating season.

Chair Frascinella said he will contact the wood carver to get them to start working on the fishing bear.

He said the other things they will consider later this year will be the bonfire. The Board said they will be looking into a location that is suitable for parking.

Mr. Adinolfo discussed some equipment they could use for next year's ice rink and the future rail trail.




