Call to Order

The Allenstown Economic Development Committee Meeting of September 14, 2022 was called to order at 6:00 pm by Chairman Mike Frascinella.

Chair Frascinella said Ms. Lemire and Nancy Beaulieu will apply for appointments at the next Selectboard meeting.

OLD BUSINESS

Cruise Night

Chair Frascinella said going back to cruise night, he only had 10 people that had signed slips and most are from out of town. He said there was some confusion having the concert at the same time as the cruise night but it was a bigger draw of people than just a concert alone.

Hometown Heros

Chair Frascinella said he has had contact with Matt Seiler because a few people had contacted him about banners. He said they now have on the town website information about how the EDC can help sponsor a banner for your favorite veteran.

He said the website also features a Spotlight on Local Businesses.

Historic Site Markers

Chair Frascinella said today he received several site descriptions from Mr. McDonald for the site markers. He said he still needs to get photographs of the sites as they look today in contrast to Allenstown of the past.

NEW BUSINESS

Halloween and Christmas Lighting

Chair Frascinella said looking at last year's contest, they had October 1-15 for submissions and October 16-29 for voting. The awards ceremony took place on October 30th.

This year, Halloween is on a Monday so they could do the awards ceremony on Saturday the 29th or Sunday the 30th. Chair Frascinella said that they have trophies and gift cards for 1st, 2nd and 3rd place.

He would prefer to have the ceremony on the Saturday afternoon, October 29th at 4 pm. Last year the awards ceremony took place at the Community Center and there were baked goods and apple cider.

Chair Frascinella said they will start planning the Christmas Lighting contest next, at the end of the month.

Local Spotlight

Chair Frascinella said that he has posted the first interview on the webpage. He has also interviewed the owner of the new storage facility on Route 28.

Ms. Lemire said that she was thinking that they could do a Spotlight on her hairdressers, Sandy Classic Touch, as their prices are very reasonable compared with other salons.

- · Why they chose Allenstown as a location.
- · What community outreach activities they have engaged in or plan to engage in.
- What are their plans for the near future.
- · The result of each interview will be a Spotlight on Business story published on this web site.

• Winter Bonfire

Chair Frascinella said they had discussed having this last winter but it was too late in the season for it.

He said two questions he has is 1) where would they get the wood, and 2) and where would they have the bonfire. Mr. Pelissier said they could do it on a skating night or during the Christmas lighting awards when people are already there.
