Old Business

May 21 Concert/ Cruise Night Wrap-up

Ms. Lemire asked the committee what they thought about the most recent Cruise Night and Concert. What went well? What didn't go as planned? How could we do things differently?

Mr. McDonald noted the vibe was good and people seemed like they were having a nice time. There were lots of people in the neighborhood around the town hall enjoying the concert from their porches or lawns. There were compliments for the band.

Ms. Beaulieu agrees with everything Mr. McDonald said. She also mentioned the crowd this year was a little bigger than last year.

Mr. Frascinella said the band got there a lot sooner than expected. They were setting up an hour before the event. The food vendor was steady from the start to the end of the event. He did a headcount twice and counted over 60 people total. He heard lots of great compliments about the band and the food.

The negative of the event was that only 7 cars showed up to the Cruise Night part of the event. Deerfield had a huge Cruise Night that was rained out Saturday night that was moved to Sunday.

Discussion ensued by the group regarding things that could have been done differently to bring more cars in and it was concluded that the rain date of the NH Muscle Car Group in Deerfield was what impacted Allenstown's event. It was their first big show with a fundraiser from 10-3.

Ms. Beaulieu said she received some feedback from someone who showed up because they got the flyer for Allenstown's event at the Candia Car Show. They said to keep passing out flyers and people will start coming. Her and Lisa plan on going back to Candia to pass out more flyers for future events.

The group continued to discuss other shows to attend and hand out flyers for Allenstown's future Cruise Nights. It was also discussed that 3 hours was better overall than 2 hours last year.

• June 25 Concert Prep

Chair Frascinella handed out some info regarding a marketing schedule to get the word out about the Cruise Night and Concert events. Mentioned they are already behind the 8 ball on the June 25, 2023 concert.

The food vendor mentioned he may hire a few kids to help him because he was so busy. Chair Frascinella spoke to Michelle Buckland and asked about a few of the students from ARD going to work with the food vendor.

Chair Frascinella said he'd like to have a Project Manager to delegate tasks according to the schedule he has created for the Cruise Night and Concerts.

• June 25 Concert Prep (Cont'd)

Chair Frascinella said an updated flyer needs to be designed, printed, and posted around town. Yard signs are ordered. Once they come in, they need to be attached to a stake. He mentioned, in a strong wind the signs are likely to bend when attached to a single stake.

• Potential New Business

Chair Frascinella mentioned a new landscaping business, Andrew Thomas Landscaping, has moved into Allenstown. They are located behind Complete Autobody next to Mega-X. Chair Frascinella is planning on doing a new business interview and spotlight.

Chair Frascinella said he was still waiting to find out if anyone is moving into the old wood priming business on 28. Also mentioned there are two empty businesses spaces next to Subway.

The group discussed how the EDC should and can be helping to promote intown businesses. It was mentioned that Sully's will be adding a walk-in beverage cooler to the end of the store closest to Dunkin' Donuts and construction is supposed to start late summer. The group can help promote businesses and things like that.

Ms. Lemire said the T-shirts should be ready by the next event. She also mentioned that she and Nancy are working on a letter to solicit donations from the businesses in town. They are hoping to have a draft within the next week or two.
