It was reconfirmed that Wednesday, February 8th would be the last day to solicit and submit survey responses., as this will provide time for Standard Power to update the Community Power Plan for final review by the Committee at a meeting planned for February 13, 2023, at which time the Committee would vote to approve the final plan, in time for inclusion in printed Town Ballots for the March 2023 Town Meeting.

Mr. McDonald discussed potentially using a public document from the City of Lebanon as a basis for the Allenstown FAQ and stated that he believed it addressed the topics the Committee wished to cover.
