# **CORRESPONDENCE & OTHER BUSINESS**

Chair O'Meara said that he and Ms. Adinolfo attended the Central NH Regional Planning Commissioner's meeting last Thursday. He said there was a keynote speaker that made a presentation on housing in NH.

Chair O'Meara said that during the Q&A portion of the presentation, they were asked what the impediments to new housing starts were in NH and the answer was required density on the zoning ordinances and education of the public regarding more dense zoning. He said going forward, he might invite them to the Board to discuss housing and the lack of new starts, particularly in Allenstown, see if they could do something about that.

Chair O'Meara said the Board could also invite input from residents and the public via public hearings. He said the aim would be to determine if there was some way to have more dense housing in some areas, and to ensure that some of the housing is affordable in nature.

Chair O'Meara said they would have to identify patches or parcels of land that could be developed for this.

Mr. Arsenault added that when there is raw land, you need a well and must be 75 feet away from a septic system. He said an overlay district would help with that, but he would like to see areas where there is available water and sewer (condominiums, duplex).

Chair O'Meara said he had not yet sent the draft fireworks ordinance to the attorneys, because he would like to bring it before the Selectboard first. Ms. McKenney said she would like to see it on the ballot for the residents to vote.
