CODE OF ETHICS FOR THE TOWN OF ALLENSTOWN

2 3 <u>PREAMBLE</u>

5	The citizens of Allenstown are entitled to a fair, ethical and accountable town government
6	and the effective functioning of democratic government requires that:
7	• All of its employees and officials, whether elected, appointed or hired comply with
8	both the letter and the spirit of the laws;
9	• All of its employees and officials, whether elected, appointed or hired be
10	independent, impartial and fair in their judgment and actions;
11	• Public Office be used for the public good, not for personal gains; and
12	• Public deliberations and processes be conducted openly, unless legally confidential,
13	in an atmosphere of respect and civility.
14	To this end, the Allenstown Board of Selectmen has adopted a Code of Ethics for all of its
15	employees and officials, whether elected, appointed or hired.

17	PURPOSE
18 19	The purpose of this code is to establish guidelines for the ethical standards of conduct for
20	employees and officials, whether elected, appointed or hired.
20	 We expect our public servants and volunteers to act in the best interest of the town.
21	 We expect our public servants and volunteers to act in the best interest of the town. We expect employees and officials, whether elected, appointed or hired to disclose
23	any personal financial or other interests in matters affecting the town that come
23	before them for action.
25	• We expect town employees and officials, whether elected, appointed or hired to
26	remove themselves from decision making if they have a conflict of interest.
27	• We expect town employees and officials, whether elected, appointed or hired to be
28	independent, impartial, and responsible to their fellow townspeople in their actions.
29	• We expect that the town's official decisions and policies be made through the proper
30	channels of government.
31	• We expect that public office or a volunteer position in our town not be used for
32	personal gain. It is important that the public has confidence in the integrity of its
33	government and that town officials, board members, volunteers and employees have
34	an opportunity to protect their personal reputation.
35	
36	This code establishes a process by which one may obtain guidance regarding potential
37	ethical issues and it establishes a course of action for resolving disputes in a manner that
38	is fair to all of the parties involved.

All of its employees and officials, whether elected, appointed or hired shall accept no assignment that could reasonably be construed as being in conflict with their responsibility to the Town of Allenstown, or in which there is an unrevealed personal interest or bias or which they are not qualified to perform.

All employees and officials, whether elected, appointed or hired must report in writing to their immediate supervisor or Board or Committee Chairperson those assignments in which they have a personal interest or bias. A personal interest or bias includes any current or any prospective or any contemplated interest or bias in the matter. A personal interest includes any ownership interest in property, employment, agency (such as an independent contractor), or business affected by the matter of the assignment. A personal bias includes a personal interest or a familial relationship to a person having a personal interest.

- 1 For one year subsequent to termination of employment, employees and a. 2 officials, whether elected, appointed or hired may not participate in any matter 3 relating to their duties and responsibilities to the Town. 4 5 2. REPRESENTATION OF PRIVATE INTERESTS BEFORE TOWN AGENCIES 6 7 No employee or official, whether elected, appointed or hired shall appear in behalf of 8 private interests before any Town Board. Officials, however, may appear without 9 compensation in behalf of constituents or in the performance of public or civic 10 obligations. This section shall not prohibit appearances upon matters only incidentally requiring official action which do not develop into a substantial part of the employment, 11 12 provided that the retainer is not for the purpose of appearing before the agency, and 13 provided, further that the compensation, in whole or in part, is not contingent or 14 dependant upon the action of such agency. 15 16 3. **REPRESENTATION OF PRIVATE INTERESTS IN LITAGATION** 17 No employee or officials, whether elected, appointed or hired shall represent private 18 19 interests in any action or proceeding against the interests of the town in any litigation to 20 which the town is a party. 21 22 4. DUTY TO DISCLOSE 23 24 All employees and officials, whether elected, appointed or hired of the Town of Allenstown 25 shall not participate in the conduct of business on behalf of the town or enter into discussion or 26 deliberation of any matter without first publicly and on the record, stating all: 27 • Dealings 28 • Interests 29 Relationships • 30 Friendships • 31 And possible conflicts 32 Which may exist between the employee or official, whether elected, appointed or hired, and their 33 family and the principals of the issue under consideration. 34 35 5 DUTY TO RECUSE IN QUASI-JUDICIAL ACTIONS 36 37 A "quasi-judicial action" is any action where a Board or Committee is acting like a judge or jury. 38 For example, when the Board or Committee has a duty to notify the potential parties, hear the 39 parties, and can only decide on the matter after weighing and considering such evidence and 40 arguments as the parties choose to lay before the Board or Committee, then it is involved in a 41 quasi-judicial action. The work of the planning and zoning boards is largely quasi-judicial action. 42 Not only do officials, board members and employees of the Town of Allenstown have a duty to 43 recuse themselves as outlined in the section above, they must recuse themselves in a quasi-44 judicial action if they would not be qualified to sit as a juror in that case. For example, jurors are
- 45 not qualified to sit in a case if they have advised or assisted either party in a matter being

1 decided, are prejudiced to any degree regarding the pending matter, or believe they cannot for 2 any reason be totally fair and impartial. As a representative of the Town of Allenstown, all 3 employees and officials, whether elected, appointed or hired are expected to hold themselves to 4 this same standard 5 6 6. CONFLICT OF INTEREST 7 8 In order to assure their independence and impartiality on behalf of the common good, all 9 employees and officials, whether elected, appointed or hired of the Town of Allenstown shall not 10 use their official positions to influence government decisions in which they have a material financial interest, or where they have an organizational responsibility or personal relationship, 11 12 which may give the appearance of a conflict of interest. 13 14 Employees and officials, whether elected, appointed or hired of the Town of Allenstown shall 15 not participate in any matter in which he/she, or a member of his/her family, have a personal 16 interest, which may directly or indirectly affect or influence the performance of his/her duties. In such instances, he/she shall recuse themselves from discussion and decision - making. 17 18 19 Recusal means to remove oneself completely from all further participation in the matter in 20 question. 21 22 All employees or officials, whether elected, appointed or hired of the Town of Allenstown who 23 have been recused shall immediately leave the room or seat themselves with the other members 24 of the public who are present. When recused, the employee or official, whether elected, 25 appointed or hired shall not participate in further discussions, unless he/she clearly state for the 26 record that he/she is doing so only as a general member of the public. As a recused person, 27 he/she shall not deliberate or vote on the matter in question. 28

All employees and officials, whether elected, appointed or hired of the Town of Allenstown shall
disclose investments, interests in real property, sources of income, and gifts; and they shall
abstain from participating in deliberations and decision-making where conflicts may exist.

7. GIFTS AND FAVORS

Officials, board members and employees of the Town of Allenstown shall not take any special advantage of services or opportunities for personal gain, by virtue of their public office that is not available to the public in general. They shall refrain from accepting any gifts (or allow acceptance of such gift by a family member), favors or promises of future benefit which might compromise their independence of judgment or action or give the appearance of being compromised.

42 Prohibited Conduct shall include knowingly accepting a gift with a value in excess of ten dollars 43 (\$150.00), or allowing acceptance of such a gift by a family member from any individual, group 44 or corporation knowingly dealing with an area of city government in which the employee or 45 official, whether elected, appointed or hired has an interest or jurisdiction. The foregoing does

46 not apply to gifts from family members.

6 insignificant in value, or an award publicly presented in recognition of public service or any gift 7 which would have been offered or given to him or her if he or she was not an Official, board 8 member or employee of the Town of Allenstown or unsolicited advertising or promotional items 9 or materials of nominal intrinsic value. 10 It shall not be a violation for an Official, board member or employee of the Town of Allenstown 11 12 to accept donations for the expressed purpose of financing a political campaign, provided that 13 such contributions are reported in accordance with all local, state and federal laws pertaining to 14 such donations or services and/or financial value. 15 16 The mere purchase of goods or services from a person or business in the ordinary course of that 17 person's or business's retail or service business shall not prevent an Official, board member or 18 employee of the Town of Allenstown from introducing, discussing, approving or voting upon a 19 mater which relates to that person or business. 20 21 8. CONFIDENTIAL INFORMATION 22 23 Officials, board members and employees of the Town of Allenstown shall respect the 24 confidentiality of information concerning the property, personnel or affairs of the town. They 25 shall neither disclose confidential information without proper legal authorization, nor use such 26 information to advance their personal, financial or other private interests. 27 28 9. USE OF PUBLIC RESOURCES 29 30 Officials, board members and employees of the Town of Allenstown shall not use public 31 resources not available to the public in general, such as town staff time, equipment, supplies or 32 facilities for private gain or personal purposes. 33 34 **10. ALLENSTOWN ETHICS COMMITTEE** 35 36 The Town of Allenstown shall establish an Ethics Committee to: 37 Educate all of its employees and officials, whether elected, appointed or hired 38 regarding the provisions of the ethics code. 39 • Provide advice and counsel to employees and officials, whether elected, appointed or hired regarding ethical issues with which they are confronted. 40 Hear and resolve ethics complaints, which are filed against employees and officials. 41 42 whether elected, appointed or hired. 43 44 45 46

This provision is not meant to apply to gifts traditionally exchanged between family members –

2 3 4 5	1. The Ethics Committee shall consist of five (5) members. A quorum of three (3) or more committee members shall be necessary to hear any complaint.
6 7 8 9	 The Ethics Committee shall be composed of the Town Moderator, the Chairman of the Board of Selectmen, the Town's Administrative Assistant and two residents appointed by the Board of Selectman to serve on the Ethics Committee for a one-year term.
10 11	3. The members of the Ethics Committee shall elect a chairperson on an annual basis.
11 12 13 14 15	4. If a complaint is filed upon a member of the Ethics Committee, that respondent shall recuse himself or herself and an alternate individual will be chosen by the Board of Selectmen to serve in their stead until the complaint is resolved.
16 17	12.10. EDUCATION
17 18 19 20 21	1. At the time that an employee or officials, whether elected, appointed or hired takes the oath of office, they shall receive a copy of this code, and acknowledge in writing that they have received a copy of this code.
22 23 24 25	2. The Ethics Committee Board of Selectmen shall hold a meeting each spring for newly hired, elected or appointed officials and employees so they may familiarize themselves with the provisions of this code.
26 27 28	3. It shall be the responsibility of the Supervisor of any new employee to ensure that the new employee familiarizes themselves with the provisions of this code.
20 29 30	<u>13.11. INQUIRIES</u>
30 31 32 33 34	The <u>Ethics Committee Board of Selectmen</u> shall establish a mechanism by which employees and officials, whether elected, appointed or hired and residents of the Town of Allenstown may obtain advice and counsel from the committee regarding ethical issues that may arise from time to time.
35 36 37	Upon request of an employee or officials, whether elected, appointed or hired, the Ethics Committee Board of Selectmen may issue a written advisory opinion in response to such an inquiry.
38 39 40 41	Such written advisory opinions will become permanent amendments to this Code of Ethics as addendum.

23 24 25 26 27 28	2.	Any employee or official, whether elected, appointed or hired against whom a written complaint is filed shall be given a copy of the complaint, and upon written request shall be afforded an opportunity to be heard and to present evidence to the Ethics Committee.
28 29 30 31 32 33 34 35	3.	The Ethics Committee Board of Selectmen shall have sole discretion for setting rules regarding the conduct of hearings. The Committee Board shall seek to make sure that both the complainant and the respondent have an opportunity to be heard and to present evidence, but the committee may limit the testimony and evidence which is presented to it if in the opinion of the committee the testimony and evidence in question is irrelevant, unnecessary, redundant, or unreliable.
36 37 38 39 40 41	4.	The Ethics Committee Board of Selectmen may require with sufficient written notice, any employee, or official, whether elected, appointed or hired, to appear before it to provide testimony regarding pending complaints. The Ethics Committee Board of Selectmen, for this purpose, may administer oaths and require the production of evidence such as documents.
42 43 44 45 46	5.	Within thirty (30) days of conducting an investigation into a written complaint, the Ethics Committee Board of Selectmen shall issue a written statement setting forth its findings. The Ethics Committee Board of Selectmen shall not have the power to impose any monetary or other penalty, only to issue a written statement as set forth above.
