Notice is hereby given in accordance with RSA 676:4 that the Allenstown Zoning Board will review the following submitted application(s) for completeness on **Wednesday, October 28, 2020, at a meeting beginning at 7:30 PM at the Allenstown Town Hall, 16 School Street, but held virtually through Zoom and Conference Call.** If the application(s) are accepted as complete by the Board, a public hearing will follow immediately after. Applications continued to a subsequent meeting will not be re-noticed.

**ZBA Case#2020-07 –1 Mount Delight Road (Lot#402 Map#150) Zoned: OSF**

**Administrative Decision:** Dimensional Restrictions (*Article VI - Section 604.c*)

A maximum of One (1) utility shed not larger than two hundred (200) square feet of floor area with a height not greater than seven (7) feet to the eaves and ten (10) feet from the floor to the ridge, need not be set back more than five (5) foot from any side or rear lot line and be no closer than six (6) feet from any residence. Requesting the structure to be classified as a Barn per **RSA 21:34**.
