TO: Kathleen Pelissier, Collector of Taxes for Allenstown, New Hampshire in said county.

In the name of the State you are hereby directed to collect the property taxes in the list herewith committed to you, amounting to the sum of Four Million Fifty Six Thousand Twenty Dollars (\$4,056,020.00) and with interest at twelve (12%) percent per annum from December 3, 2018 thereafter, on all sums not paid on or before that day.

And we further order you to remit all monies collected to the Town Treasurer, or to the Town Treasurer's designee as provided by RSA 41:29, VI, at least on a weekly basis, or daily whenever tax receipts total One Thousand Five Hundred Dollars (\$1,500.00) or more.
