| Tuesday, January 8, 2019 | Last Day for giving notice of public hearing for annual budget if to be held on January 15, 2019 Last Day for Selectboard to publish a notice of time, place, and subject of public hearing on bond or note issue over \$100,000. Hearing can be held no earlier than 60 Days before 1 st Session Last Day for Voters to petition Selectboard to include an article in the town meeting warrant. {RSA 39:3; 40:13, II-a(b)} |
| Friday, January 11, 2019 | Last Day for governing body to vote to extend polling hours at March 12, elections. [RSA 659:4-a, IV](Note: Reduction of polling place hours requires vote of legislative body) |
| Saturday, January 12, 2019 | <u>Budget Committee public hearing on the budget and all warrant articles that include appropriations.</u> |

| Saturday, January 15, 2019 | <u>Last day to hold at least one public hearing on annual budget and articles with an appropriation [RSA 32:5, I and V; 40:13, II-a (c)]</u> Last day to hold public hearing on bond or note issue over \$100,000) (Can't be held more than 60 days before first session) |
| Friday, January 18, 2019 | Last day to hold public hearing on question of establishing a special revenue fund if the first session is to be held on February 3rd. Hearing must be held at least 15 but not more than 30 days prior to meeting where question will be voted on. (RSA 31:95-d,I(b)) |
| Thursday, January 24, 2019 | Last day for the Budget Committee to submit its annual budget to the Board of Selectmen. |
