# **EXECUTIVE SUMMARY**

# Scope of Work

Hubbard Consulting LLC proposes to conduct a Full-Scale Active Shooter Exercise for the Town of Allenstown. The exercise will meet the requirements of the US Homeland Security Exercise and evaluation Program (HSEEP), the NH Department of Safety/Division of Homeland Security and Emergency Management, the Town of Allenstown, NH.

Hubbard Consulting LLC will complete the following Tasks to coordinate and facilitate the Full-Scale Exercise which meet the recommendations of HSEEP. Hubbard Consulting LLC will work closely with the Police Chief, Emergency Management Director and other local officials as necessary, in order to obtain the proper information to complete the tasks below.

#### Full-Scale Exercise Tasks:

The Town of Allenstown is looking to exercise the town's emergency response to an active shooter at a local school. The Full-Scale Exercise will utilize a Sim-cell and an incident command post. The targeted audience will be Allenstown police, fire and EMS officials. The following tasks will be completed for the development and implementation of the Full-Scale Exercise:

#### TASK 1: CONCEPTUAL DEVELOPMENT MEETING

- Meet with Police Chief, EMD and/or other representatives to discuss process and timeline.
- Define Scope.
- Identify Exercise Design Team.
- Set date for initial Planning Conference.

#### TASK 2: INITIAL PLANNING CONFERENCE

- Convene the Design Team (EMD, Police, Fire, etc).
- Provide orientation to Design Team.
- Review Scope.
- Develop Statement of Purpose.
- Develop the Exercise Directive.
- Identify Exercise Objectives.
- Set date(s) for Full-Scale Exercise.

#### TASK 3: DEVELOP SCENARIO NARRATIVES

- Under the scope of the grant develop narratives that compliment the exercise objectives.
- Prepare rough draft of Master Sequence of Events List based upon finished objectives.

#### TASK 4: FINAL PLANNING CONFERENCE

- Finalize Master Sequence of Events List based.
- Complete the exercise package (Explan & C/E Manual) and distribute to participants prior to the exercise.

#### TASK 5: FULL-SCALE EXERCISE:

■ Conduct Full-Scale Exercise (Fall 2017).

#### TASK 6: CONDUCT AN AFTER ACTION REVIEW:

- Coordinate with agency heads.
- Develop an After Action Report (AAR) for Allenstown.
- Submit Draft AAR to participants for review/comment.
- Develop Corrective Action Plan (a.k.a. Improvement Plan).
- Finalize the AAR for the Town Allenstown.
- Final meeting with agencies to review AAR and Corrective Action Plan.

#### **Exercise Work Products**

Allenstown will receive one digital and five hard copies of the After Action Report (AAR) for the Full-Scale Exercise. In addition, the Exercise Training Coordinator at HSEM will receive one copy of the AAR. At a minimum, the AARs will include:

#### Executive Summary:

Briefly describes a summary of the information contained in the AAR, including an overview of the exercise, major strengths demonstrated and areas that require improvement.

#### Exercise Overview:

Briefly describes details of exercise, identifies participants, the exercise structure and how it was implemented.

#### Exercise Goals and Objectives:

List the goals and objectives developed during the exercise planning and design phase.

#### Exercise Events Synopsis:

According to the objectives identified for the Exercise, each evaluator is assigned an expected action to record for each event scenario. The Expected Action Matrix provides an overview of the scenarios presented and the expected actions for the players.

#### Analysis of Objective Performance:

The Analysis of Objective Performance Matrix provides an overview of each expected action and whether or not it was met and what improvements are recommended.

#### Corrective Actions:

Reviews the performance of individual tasks and objectives as defined in the evaluator checklists. A Corrective Action will be identified for those tasks that were not performed as expected.

# **Proposed Work Schedule**

The exact timeline of the exercise is not yet established. However, it is anticipated that the Active Shooter Full-Scale Exercise will occur in the fall of 2017. The documents for the Exercise, as identified in the sections above, will be completed no later than December 31, 2017.

# **Budget**

The total cost to meet the Proposed Work Plan and Work Products will not exceed \$13,200. The costs for each exercise are outlined in the table below. Costs include management of the grant, meeting preparation, coordination of meetings, distribution of documents, travel expenses, evaluators/contractors and cost of supplies. Invoices will be submitted on a monthly basis. Any match for grants provided to the Town will not be covered by Hubbard Consulting LLC; however, Hubbard Consulting will assist the Town with grant reporting requirements.
