# • Fire Department New Hires and Fire Chief Stuff

Chief Lambert stated he is going to postpone the new hires discussion for two weeks. He also stated that they are going to have to wait until next year to apply for any grants for apparatus. A town the size of Allenstown has a cap on how much can be asked for. He said the grant writer they now have does a great job writing the grants and he is very impressed. He let the board know their ambulance will be pushed out until June 2025.

Mr. Pelissier is suggesting Mihachik Builders for \$17,664.00. He lives in town and has done other work for the town.

The insurance should pay for the removal of it. He will talk to the mobile home guys who pull these out. He does not know the exact cost yet. They have to do a mitigation for asbestos as well. Brian Arsenault said it could cost up to \$10,000.
