NOTICE OF PAST VIOLATION

Dear Mr. Boranian:

The purpose of this Notice of Past Violation is to notify Perfect Fit Yarn, LLC (Perfect Fit) that the New Hampshire Department of Environmental Services, Air Resources Division, (NHDES) has identified a violation, listed below, related to State Permit to Operate No. SP-0037 (the Permit). On December 15, 2014, NHDES issued the Permit to Perfect Fit authorizing the operation of two boilers located at 25 Canal Street in Allentown, New Hampshire. The Permit expires on December 31, 2019.


- Env-A 705.01, Env-A 705.04(a), and Condition VIC, Table 5, Item 3 of the Permit require Perfect Fit to annually submit emission-based fees, by April 15 for emissions from the previous calendar year, for all devices required to be permitted. Perfect Fit did not submit the annual emission fee for calendar year 2015 until June 24, 2016.

NHDES believes that no further action in response to the listed violation is required. NHDES requests that Perfect Fit comply with all obligations contained in the Permit, including the requirement to make a timely application to renew the Permit at least 90 days prior to its expiration date. **Also, please be advised that the annual emission report and emission-based fees for calendar year 2016 emissions are due by April 15, 2017.**

In the event that other violations are identified or if Perfect Fit fails to comply with all applicable requirements in the future, NHDES may take action against Perfect Fit, including issuing an administrative order, seeking administrative fines, and/or referring the matter to the NH Department of Justice for civil penalties.
