- Identify next steps and timing to support implementation of the Power Plan

There was a general discussion on the next steps for implementation of the Power Plan. The Plan is currently awaiting review and approval by the PUC, with a decision expected by the end of May. Once that occurs, the following steps will take place to advance the implementation of the program:

- Solicit Pricing
- Obtain Data from Eversource
- Obtain Rates
- Develop Mailings for Town Residents. Note: Standard Power to provide examples of communications used for the Town of Keane
- Develop Contracts and finalize Pricing

It was noted that Derik Goodine is the official approver of documents related to submission to the PUC.

Standard Power opined that the anticipated start date for Allenstown would be late September or early October, 2023, and that fixed rates would be determined in the June/July time frame.

- Mr. Manoj Timilsina, a resident of Chester Turnpike in Allenstown who was present at the meeting, stated that he had been considering a solar installation which will not now be moving forward for unrelated reasons, and expressed his thanks and support for the effort being put forth by the Committee to reduce energy prices for town residents.
