On behalf of Chairman Richard Caruso, Mr. O'Meara read the authorization to hold the meeting electronically and the instructions for participation.

Review Q1 2021 Financial Statements (Jan – Mar 2021)

Mr. O'Meara reported the following Trust Fund market value balances relevant to third quarter performance:

January 01, 2021 \$2,393,740.49. January 31, 2021 \$2,386,934.10.

February 28, 2021 \$2,377,618.95, for an unrealized loss of \$10,426.55.

March 31, 2021 \$2,378,715.44. The unrealized loss for the quarter was \$6,044.19.

Mr. O'Meara stated that, given the volatility of the market, the funds are doing well.

 Request from the Select Board for the transfer of \$244,900.00 from the town's general operating account to the Capital Reserve accounts in accordance with the votes taken at Town Meeting on March 09, 2021. The voters authorized the transfer of funds from the Unassigned Fund Balance to the Capital Reserve Funds as follows:

Mr. O'Meara called for a roll call vote on the motion. Chair Caruso – Aye, Mike O'Meara – Aye.

Voted unanimously in favor (2-0).

Other business

Ms. Bender stated that TD Wealth Management was asked in December of 2020 to close the School Facilities Trust Fund, and they have informed her that it will show as closed on the April 2021 statement. Mr. O'Meara explained that this is a School-side account.

Mr. O'Meara reported that he has completed the Auditor's Questionnaire, which he does annually on behalf of the Trustees. He also asked for consent to interact on behalf of the Trustees to interact with the Auditors electronically during the auditing process.

Chair Caruso and Finance Director Bender gave verbal consent.

 Cemetery Trustees - Status of the legal agreement being developed between the Town of Allenstown and the Catholic Diocese of Manchester to permit the transfer of monies and future management of certain perpetual funds to that Diocese.

Ms. Bender reported that she sent a document to the Diocese to review. It has been sent to their legal group for review and revision. It is not yet ready.

Mr. O'Meara asked Ms. Bender to let the Diocese know that they would like to have the revised document back by the end of May, as the town's legal counsel has to review the document as well.

Confirm date for next meeting

Mr. O'Meara announced July 28, 2021 at 10:00 am as the scheduled date and time for the next meeting.
