

- Allenstown Welcome Banners: 1. Report on contact with Signworld as a possible vendor (Maureen). 2. Review Chad and Mike's locations for US flags and Welcome banners. 4. Finalize the number of flags and banners to order (Cap. Reserve Fund at about \$2,000). 5. Determine a vendor and cost for US flag kits (3x5 ft.).
