**BUDGET COMMITTEE MEETING**

As Chair of the **Allenstown Budget Committee, I, Keith Klawes**, find that due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, this public body is authorized to meet electronically.

Please note that the meeting will be held at the Allenstown Community Center (Space is limited, and we ask that non-committee members or presenters please RSVP with Town Administrator at 603-485-4276 X112 to make sure there is safe space for your attendance at the meeting) as well on Zoom and Zoom Conference Call, which was authorized pursuant to the Governor's Emergency Order. However, in accordance with the Emergency Order, I am confirming that we are:

*a) Providing public access to the meeting by telephone, with additional access possibilities by video or other electronic means:*

We are utilizing a **Zoom Video Conferencing, (We will also be attempting to use Facebook Live as long as bandwidth allows as a redundant video source)** for this electronic meeting. In the event the public is unable to access the meeting, the meeting will be adjourned and rescheduled. **The Meeting will only be adjourned if the phone number line of the zoom fails to work. The meeting may be paused if the video links fail and a quorum of the Budget Committee is needed through the phone in method.**

Please note that **all votes** that are taken during this meeting shall be done by **roll call vote**.

**The Meeting will start by taking a roll call attendance. (When each member states their presence, please also state whether there is anyone in the room with you during this meeting, which is required under the Right-to-Know law.)**

**We will also attempt to capture people remotely attending the meeting.**
