

Town of Allenstown Remote Viewing and Listening Instructions BUDGET COMMITTEE METING October 15, 2020

As Chair of the <u>Allenstown Budget Committee</u>, I, <u>Keith Klawes</u>, find that due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, this public body is authorized to meet electronically.

Please note that space is limited at the meeting location at the Allenstown Community Center at 8 Whitten Street; However, in accordance with the Emergency Order, I am confirming that we are:

a) Providing public access to the meeting by telephone, with additional access possibilities by video or other electronic means:

We are utilizing a Zoom Video Conferencing, (We will also be attempting to use Facebook Live as long as bandwith allows as a redundant video source) for this electronic meeting. All members of the Budget Committee have the ability to communicate contemporaneously during this meeting through this platform, and the public has access to contemporaneously listen and, if necessary, participate in this meeting through dialing the phone number listed below (Not the local conference call due to the location), or by clicking on the website address link below, or type it into your browser (You may need to download Zoom software to participate):

In the event the public is unable to access the meeting, the meeting will be adjourned and rescheduled. <u>The Meeting will only be adjourned if the phone number line of the zoom fails to work.</u> <u>The</u> <u>meeting may be paused if the video links fail and a quorum of the</u> <u>Budget Commitee</u> is needed <u>through the phone in method.</u>

Please note that **all votes** that are taken during this meeting shall be done by **roll call vote**.

<u>The Meeting will start by taking a roll call attendance.</u> (When each member states their presence, please also state whether there is anyone in the room with you during this meeting, which is required under the Right-to-Know law.)

We will also attempt to capture people remotely attending the meeting.
