As Chair of the Allenstown Budget Committee, I, Keith Klawes, find that due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, this public body is authorized to meet electronically.

a) Providing public access to the meeting by telephone, with additional access possibilities by video or other electronic means:
