

Town of Allenstown Remote Viewing and Listening Instructions Selectboard Meeting July 13, 2020 \*\*\*\*\*\*

As Chair of the <u>Allenstown Board of Selectman</u>, I, <u>Sandra McKenney</u>, find that due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, this public body is authorized to meet electronically.

Please note that there is no physical location to observe and listen contemporaneously to this meeting, which was authorized pursuant to the Governor's Emergency Order. However, in accordance with the Emergency Order, I am confirming that we are:

a) Providing public access to the meeting by telephone, with additional access possibilities by video or other electronic means:

We are utilizing a <u>Conference Call line, and Zoom Video Conferencing, (We will also be</u> <u>attempting to use Facebook Live as long as bandwith allows as a redundant video source)</u> for this electronic meeting. All members of the Board of Selectmen have the ability to communicate contemporaneously during this meeting through one of these platforms, and the public has access to contemporaneously listen and, if necessary, participate in this meeting through dialing the following <u>phone # 603-485-7321 and password 1234</u>, or by clicking on the website address link below or type it into your browser (You may need to download Zoom software to participate):

The meeting may be</u> <u>paused if the video links fail and a quorum of the Selectboard is needed on the conference</u> <u>call.</u>

Please note that **all votes** that are taken during this meeting shall be done by **roll call vote**.

<u>The Meeting will start by taking a roll call attendance.</u> (When each member states their presence, please also state whether there is anyone in the room with you during this meeting, which is required under the Right-to-Know law.)

We will also attempt to capture people remotely attending the meeting.

<u>Conference Phone First and then Zoom Video Participants. We ask that Facebook Live viewers type</u> their names into the comments box, so we can capture you for attendance also.
