

Town of Allenstown Remote Viewing and Listening Instructions Selectboard Meeting November 02, 2020 \*\*\*\*\*\*

As Chair of the <u>Allenstown Board of Selectman</u>, I, <u>Sandra McKenney</u>, find that due to the State of Emergency declared by the Governor as a result of the COVID-19 pandemic and in accordance with the Governor's Emergency Order #12 pursuant to Executive Order 2020-04, this public body is authorized to meet electronically.

Please note that there is no physical location to observe and listen contemporaneously to this meeting, which was authorized pursuant to the Governor's Emergency Order. However, in accordance with the Emergency Order, I am confirming that we are:

a) Providing public access to the meeting by telephone, with additional access possibilities by video or other electronic means:

We are utilizing a <u>Conference Call line, and Zoom Video Conferencing, (We will also be</u> <u>attempting to use Facebook Live as long as bandwith allows as a redundant video source)</u> for this electronic meeting.
