

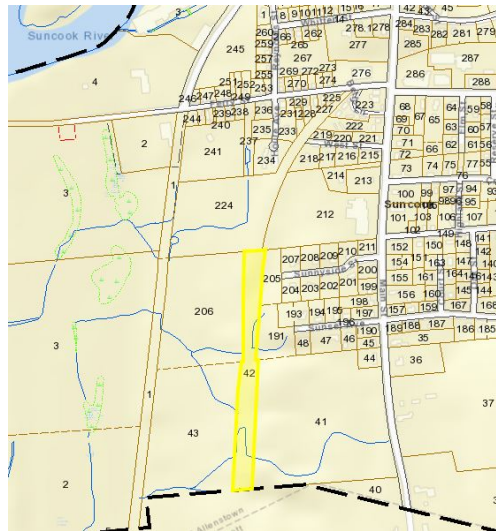

**Allenstown Selectboard**  
**will hold a**  
**Public Hearing on Purchase of Land Identified as Map and Lot**  
**113-042 by the Town of Allenstown as part of Acquisition of old**  
**rail properties for Recreation Trail Use**  
**October 19, 2020**  
**at 6:00PM at the Allenstown Town Hall**



There will be a public hearing in accordance with NH RSA 41:14-a on the purchase of a parcel of land to supplement the two parcels of land which were previously approved to be acquired by the Board of Selectmen. The originally approved parcels are Map 114, Lot 001 and Map 115, Lot 001 and are located across from Canal Street with road frontage on Ferry Street. The additional parcel is Map 113, Lot 42. The Town proposes to build trails on the originally approved parcels of land and link them to the Hooksett Rail Trail which is adjacent to the Merrimack River and which trails will eventually cross the Suncook River to the Town of Pembroke. If approved by the Board of Selectmen, Map 113, Lot 42 will be acquired as a package with the originally approved parcels.
