SCOPE OF SERVICES:

The applicant (Casella Waste Management) has submitted an application, site plans and related documents to the Town of Allenstown for proposed drainage improvements on Map 105/Lot 38 in Allenstown. The site is located at 104 River Road within the Commercial Industrial Zone. The applicant is proposing to construct drainage improvements for the purpose of managing stormwater.
