Billing Rules:

- 1. The approved Fee Schedule will generally apply to all services indicated in the billing schedule.
- Residence of Allenstown and Pembroke who have Medicare and no other supplemental insurance will not be sent to collections if they are unable to pay the 20% co-pay (Medicare pays 80% of Medicare allowable). Proof of residency will be required.
- 3. Residences of Allenstown and Pembroke who do not have any insurance will have their ambulance bill from Tri-Town EMS reduced to Medicare allowable. Proof of residency will be required.
- 4. Tri-Town EMS will not charge employees, of the Town of Pembroke or the Town of Allenstown for ambulance transport beyond that what their health insurance pays.
- 5. Tri-Town EMS will not charge departments or their employees of the Town of Pembroke or the Town of Allenstown for CPR courses.
- 6. Tri-Town EMS will not charge its employees or their spouse and non-adult children for any transport beyond that which their health insurance pays.
- 7. Tri-Town EMS will not charge its employees for any CPR, refresher or licensing course offered by the Service. Family members of Tri-Town EMS employees will not be charge for a CPR course.
