# CO 315 An Ordinance Regulating Town-Owned Lands

## CO 315:1 Authority

The Select Board hereby adopts the following Ordinance Regulating Town-Owned Lands pursuant to N.H. Rev.Stat.Ann. ("RSA") 41:11-a (as amended).

#### CO 315:2 General Prohibition

- (a) It shall be unlawful for any person to enter upon, use or otherwise utilize in any way any Town-Owned Lands with without specific written permission from the Select Board or its designee.
- (b) "Town-Owned Lands," for the purpose of this Ordinance, shall mean any parcel of real property under the direct control of the Select Board or their designee and not otherwise directly managed by any other Board, Commission or Department.

### CO 315:3 Conduct Prohibited on Town-Owned Lands

The provisions of CO 315:2 notwithstanding, specific Town-Owned Lands set out in CO 315:4 or that may be designated by the Select Board from time-to-time, shall be subject to the following regulations:

- (a) solicit money, subscription, alms or contributions for any purpose;
- (b) advertise in any manner whatsoever for any reason whatsoever;
- (c) deface, destroy or remove any sign, bench, fence, or other structure, or any plant material existing on Town-owned land, except for forest management practices specifically authorized by law;
- (d) kindle or maintain a fire without prior permission from the Superintendent of Town lands and the appropriate permit;
- (e) deposit, drop or leave any debris, refuse or other litter of any kind;
- (f) operate on or bring onto Town-owned land any motorized vehicle, including, but not limited to, automobiles, trucks, motorized trail bike or other off-highway recreational vehicle without prior permission from the Superintendent of Town lands and the appropriate permit;

- (g) to exhibit, sell, offer for sale, hire, lease or rent any object, service or merchandise; or
- (h) to enter or remain on Town-owned land for the purpose of overnight camping; or,
- (i) to deposit on Town-owned land any human waste, hazardous waste, animal waste, garbage, or any other substance whatsoever that poses a threat to public health or safety.

## CO 315:4 Designation of Particular Town-Owned Lands

The Select Board hereby designates the following parcels as subject to the regulations contained in CO 315:3:

- (a) Tax Map 402, Lot 109: 27 acres on Dowst Road;
- (b) Tax Map 402, Lot 109-001: 17.8 acres on Deerfield Road;
- (c) Tax Map 402, Lot 115: 4.4 acres on Pauper Road;
- (d) Tax Map 402, Lot 116: 9.2 acres on Pauper Road;
- (e) Tax Map 407, Lot 039: 15 acres, rear Route 28;
- (f) Tax Map 410, Lot 023: 7.6 acres, rear Granite Street;
- (g) Tax Map 410, Lot 025: 5 acres, off Granite Street Extension;
- (h) Tax Map 410, Lot 029: 15 acres, rear Granite Street Extension;
- (i) Tax Map 410, Lot 031: 23 acres, rear Granite Street Extension;
- (j) Tax Map 410, Lot 032: 8.7 acres, rear Granite Street Extension;
- (k) Tax Map 410, Lot 035: 25 acres, rear Podunk Road;
- (I) Tax Map 411, Lot 004: 31 acres, rear Old Chester Turnpike;
- (m) Tax Map 411, Lot 005: 97 acres, rear Old Chester Turnpike.

### CO 315:5 Superintendent

The Town Administrator shall act as superintendent of Town-owned property as agent for the Select Board.

## CO 315:6 Enforcement

- (a) The enforcement of this ordinance shall be the responsibility of the Allenstown Police Department.
- (b) Any violation of this ordinance shall be considered a violation as set out in RSA 651:2 and shall upon conviction result in a fine being imposed in an amount not to exceed \$1,000.00.
- (c) Any person, who because of their behavior or violation of this Ordinance, may upon notification from the Superintendent and/or the Chief of Police be prohibited from entrance onto Town-owned land.

# CO 315:7 Effective Date

This Ordinance shall be effective upon passage.
