## Review Q2, 2020 financial statements (April - June 2020)

Mr. O'Meara reported that the market value of the Trust Funds as of the beginning of Q2 was \$1,955,345.45. At the end of April, that value was \$1,963,467.09; at the end of May the market value was \$2,191, 963.46; and at the end of June it was \$2,199,440.95. From these values, he said, it appears that their investment strategy is working well.

## Withdrawal from Highway Department Equipment Capital Reserve Fund (CRF)

Mr. O'Meara stated that a document from the Select Board dated July 27, 2020 requests a withdrawal from the Highway Department Equipment CRF to reimburse the town for a partial down payment on a 2021 International Plow Truck HV 507, the amount of \$23,000 to be transferred to the General Fund

account ending in 8125. An invoice from Liberty International Trucks, LLC states that the full cost of the vehicle is \$172,115.00. A signed credit application with Tax Exempt Leasing Corporation includes a quote for the lease payment.

Mr. O'Meara asked for, and received, the consent of all Trustees for this transaction.

Mr. O'Meara reported that he had received the Annual Trustees of the Trust Funds questionnaire, which he filled out on behalf of the Trustees. It asked for information about 'what we are and what we do,' he said.
