

MEETING MINUTES TRUSTEES OF THE TRUST FUNDS **CEMETERY TRUSTEES** 16 School Street, Allenstown, NH 03275

May 24, 2023

CALL TO ORDER

The Allenstown Trustees of the Trust Funds and Cemetery Trustees meeting of May 24, 2023 was called to order by Chair Ron Adinolfo at 5:00 pm. Chair Adinolfo called for the Pledge of Allegiance.

CEMETERY TRUSTEES

 Update on the status of the transfer of monies and future management of certain perpetual funds from the Town Cemetery Trustees to the Catholic Diocese of Manchester.

Michael O'Meara changed the document to remove Trustees of the Trust and add Cemetery Trustees as they are two different entities in this case. He will confirm with legal to verify that is correct.

Ron Adinolfo stated the Diocese is waiting on us. The Trustees should update the amounts to reflect 2022 as it currently reflects 2020.

Michael O'Meara asked Sherry Miller to provide the ending numbers for 2022 to update the schedule and move it along to the Diocese to see if we can bring this to a closure.

Chair Adinolfo stated he did some research and one of the individuals is actually buried in Massachusetts. Louise Evans, who we hold a trust for, is buried in Mt. Auburn Cemetery in Cambridge, MA. There is one other individual they cannot find where he is buried. The Cemetery Trustees only need to meet once per year once this is cleared up.

OTHER BUSINESS

Chair Adinolfo stated that he and Mike O'Meara discussed getting together some Capital Reserve Fund documentation. What are the policies and procedures to do this. They further discussed taking some of the burden off the Town Administrator, Derik Goodine. They decided to work with Sherry to work all the standardized forms together for when funds are requested. It will streamline things and help us keep track of all the things going on.

Sherry Miller can then forward us the forms once they have gone to the Board of Selectmen and been signed. He is hoping to get the books reconciled and all the forms squared away by the next meeting and would like the Board to meet monthly until this is done.

Chair Adinolfo stated he would like to ask all the Department Heads to give them a list of their anticipated Capital Reserve Funds requests for a particular budget year so that they know what might be coming through and if there is anything mid-year, they can email Sherry Miller and it can be added to the spreadsheet so they an see it is coming and will give her some kind of forecast as to what the expenses may be moving forward.

Chair Adinolfo also stated that he would like to get, along with a list of the trust funds, the associated warrant articles. This would be helpful as some times there is a question on whether or not an expenditure is appropriate for a particular trust fund.

Chair Adinolfo informed the board that he will be attending a Trustees Training on June 8th. He will get a video of the training and if Mr. Goodine could get him some thumb drives he will put the video on to pass out to the board members. He also stated he will be speaking to the new investment person to get him on board for their next meeting in June.

• Confirm date for next meeting – Discuss meeting date/time for June 2023.

The Board discussed possible meeting dates of June 13, 15, 20 or 22nd. Once they know when the investor is available, Ron Adinolfo will email the Trustees with the date.
