

# MEETING MINUTES TRUSTEES OF THE TRUST FUNDS CEMETERY TRUSTEES 16 School Street, Allenstown, NH 03275 October 25, 2023

### CALL TO ORDER

The Allenstown Trustees of the Trust Funds and Cemetery Trustees meeting of October 25, 2023 was called to order by Chair Ron Adinolfo at 5:00 pm. Chair Adinolfo called for the Pledge of Allegiance.

### **Agenda Items:**

Financial Statement Review Chair Adinolfo reviewed the latest account statement as of September 30, 2023, which again showed a loss for the year, primarily due to ongoing fluctuations in the financial markets, and management fees being paid to the current financial institution that manages the investment portfolio. Current yield on investments is approx. 2.11%.

### • Transition to NHPDIP

Chair Adinolfo provided a status update on the transition to NHPDIP. All required forms, except Contact Information Forms, are with NHPDIP. The last remaining signature on a Contact Form was gathered at the meeting, and all forms will be mailed to NHPDIP on Thursday, October 26<sup>th</sup>. The goal remains to complete the transition by the end of November, 2023.

### • Review/approve minutes from prior Trustee meeting(s):

### • CEMETERY TRUSTEES

# • Update on the status of the transfer of monies and future management of certain perpetual funds from the Town Cemetery Trustees to the Catholic Diocese of Manchester.

Review of the proposed Non-Judicial Settlement Agreement (NJSA) was completed by Town and Diocesan attorneys, and the final version has been provided for both Select Board and Trustee Signatures. The NJSA will be presented to the Select Board at their November 16, 2023 meeting, and if approved, will be followed by Trustee approval to fully execute the Agreement, at which time funds can be transferred from the custody of the Trustees to the Catholic Diocese of Manchester. It was noted that this will leave three (3) Perpetual Funds in the custody of the Cemetery Trustees. It has been previously confirmed that two (2) of the decedents are interred in Massachusetts, and the third is believed to be interred on private land in Allenstown.

As none of the decedents are interred in a Public Cemetery in Allenstown, the Cemetery Trustees will next work to address the statues of the remaining Perpetual Funds, as none can be used by the Trustees for their intended purpose.
